OPERATING BUDGETS

On Monday, the **Milwaukee County Board's Finance & Audit Committee** voted to approve the following 2010 Budgets on the following votes:

- 4-2 (No-Mayo, Jursik) State Shared Taxes
- 6-0 County Sales Tax Revenue
- 5-1 (No-Mayo) Power Plant Revenue
- 5-1 (No-Mayo) Surplus (or Deficit) from Prior Year
- 6-0 Offset to Internal Service Charges
- 6-0 Charges to Other County Organization Units
- 5-1 (No-Mayo) Capital Outlay/Depreciation Contra
- 4-3 (No-Mayo, Jursik, Coggs) on General County Debt Issue
- 5-2 (No-Mayo, West) on Debt Issue Expense

- Appropriation for Contingencies (laid over until call of Chair)
- County General Debt Issue (laid over until Capital Budget)

- Medicare Part D Revenue (laid over until call of Chair)
- Register of Deeds (laid over pending a legal opinion from Corporation Counsel)
